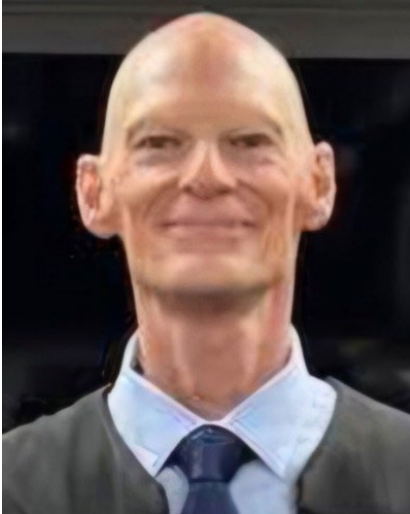


# Justice of the Peace, Precinct 1, Place 2
