Ryan Luna


Judge Ryan Luna was appointed to the 414th Judicial District Court by Governor Greg Abbott in December, 2023.

Judge Luna previously served as judge of McLennan County Court at Law #3. Before joining the bench, Judge Luna was in private practice where he represented plaintiffs and defendants in state and federal court.

Judge Luna graduated from Baylor University with a B.B.A. and earned his law degree from Baylor Law School. During law school, Judge Luna interned at the Texas Supreme Court for Justice Eva Guzman, clerked at the Texas Attorney General's office, and worked for a legislator in the Texas House of Representatives. Judge Luna is a member of the State Bar of Texas, the Texas Bar College, and the Judge Abner V. McCall Inn of Court.

Judge Luna is also involved in the community. He serves on the McLennan County Juvenile Board, the Adult Probation Board, the McLennan Bar Association Board, and the Waco Symphony Board. He has also served as the pro bono legal clinic director at Mission Waco, served on the Waco Transit Advisory Board, the McLennan County Young Lawyers Association Board, and the Care Net Pregnancy Center of Central Texas Board. Judge Luna is also a proud graduate of Leadership Waco. He and his wife, Genesis, have four children.

I became board certified in criminal law in 2007 by the State Board of Legal Specialization.

On February 2, 2017, I assumed the bench of County Court at Law #1 and held the position since. My docket consists of criminal (both felony and misdemeanor) cases and general civil cases (except for family law) and contested probate matters. I also serve as the administrative judge for the County Courts at Law for McLennan County.

I also serve as an adjunct professor at the Baylor School of Law, teaching Juvenile Justice and coaching a Client Counseling Team.

Judge Brad Cates was elected to the McLennan County Court at Law No. Two in 2010, and has served on the bench from 2011 to the present. He was a member of the Baylor University Class of '77, where he earned a B.B.A., and received his law degree from Baylor Law School in 1980. He was licensed by the Texas Supreme Court in May, 1981.

Judge Cates created standardized criminal and civil digital forms which can be completed on computer and printed, assuring a consistent and reliable forms practice for attorneys. Judge Cates was also instrumental in developing an electronic monitoring program in 2012, which has both alleviated jail overcrowding and saved McLennan County multiple millions of dollars in jail housing expenses.

Judge Cates was recognized as "Outstanding Mentor" in 2018 and served as a member of the Board of the Judicial Section of the State Bar of Texas from 2012 to 2015, and from 2016 to 2018. He is married to Linda Bates Cates, a Waco native, and is the proud father of two and the proud grandfather of six. He performs with his church orchestra, loves all forms of music, and, occasionally, performs professionally. He is also an avid woodworker, outdoorsman, reader, and handyman.
